Candidates who did not appear for CUET (UG) 2025 may be considered for **spot admissions**, subject to availability of vacant seats after the CUET-based admission rounds. Details of spot admissions (if any) will be notified separately on the university website.

Seat allotment will be done in person during the counselling process, strictly based on CUET (UG) merit and applicable reservation norms. **Candidates must be physically present to be considered for admission.**
