No extension of the prescribed last date shall be granted.

2. Candidates whose names appear in Selection List - III shall pay the prescribed Admission Fee as mentioned in the fee table provided for the respective programme.
3. The Admission Fee shall be paid on or before **15 August 2026**.
4. The Admission Fee may be paid either by scanning the QR Code provided by the University or through the Bank Account details notified by the University.
5. After successful payment, candidates shall complete the prescribed Google Form and upload the Admission Fee payment receipt along with all other required details/documents on or before **15 August 2026**.
6. Candidates must ensure that the payment receipt uploaded is clear, legible, and corresponds to the Admission Fee paid for the programme for which admission is being offered.
7. Candidates shall retain the original payment receipt and produce the same at the time of document verification/admission, if required.
8. Payment of the Admission Fee alone shall not be treated as final confirmation of admission. The admission shall be confirmed only after successful verification of eligibility, original documents, completion of all prescribed formalities, and approval by the University.
9. Candidates who fail to pay the Admission Fee and submit the required Google Form and documents within the prescribed deadline shall be treated as having not accepted the admission offer, and the offered seat shall stand forfeited.
10. No extension of the last date of **15 August 2026** shall be granted under any circumstances.
11. Any seat remaining vacant after the prescribed deadline shall be offered to the next eligible candidate(s), wherever applicable, through a subsequent Selection List/admission process in accordance with the merit, applicable reservation policy, seat availability, and University rules.

General Instructions

1. This Selection List – III (Against Vacant Seats) has been prepared on the basis of merit, applicable reservation policy, seat availability, and the eligibility criteria prescribed by Sammakka Sarakka Central Tribal University.
2. Candidates whose names appear in this Selection List are offered admission against the available vacant seats in the respective programme, subject to successful verification of eligibility, original documents, category/reservation claims, and completion of all prescribed admission formalities.
3. Inclusion of a candidate's name in this Selection List does not constitute final confirmation of admission. Admission shall be confirmed only after successful verification of eligibility and documents, payment of the prescribed Admission Fee, submission of the required details/documents, and approval by the University.
4. Candidates are advised to carefully verify the eligibility criteria prescribed for the respective programme before making the payment. If a candidate is subsequently found ineligible or any information/document furnished is found to be false, incorrect, invalid, or misleading, the candidature/admission shall be cancelled as per the rules of the University.
5. Registration Fee – Special Provision: The University observed that some candidates had completed and submitted their application forms but, due to difficulties in uploading the Registration Fee payment receipt on the admission portal, could not complete the corresponding payment/upload formalities. As a one-time special provision, such candidates have been considered for the admission process.
6. Candidates who have not yet paid the prescribed Registration Fee or have not completed the applicable Registration Fee payment/upload formalities shall complete the same on or before **15 August 2026**. Candidates whose required Registration Fee formalities are not completed within the stipulated time shall not be considered for further processing of admission.
7. Candidates offered admission under this Selection List shall complete the prescribed admission formalities within the stipulated time. Failure to complete the admission process within the prescribed time shall result in forfeiture of the offered seat.
8. Any seat remaining vacant due to non-payment of the Admission Fee, non-submission of the required documents/details, non-reporting, withdrawal, cancellation, or any other reason may be offered to the next eligible candidate in accordance with the merit, applicable reservation policy, and rules of the University.

9. Candidates are advised to regularly visit the official University website for further updates, notifications, and subsequent Selection Lists, if any. The University may publish further Selection Lists depending upon the availability of vacant seats and the applicable admission rules.
10. The decision of Sammakka Sarakka Central Tribal University on all matters relating to admission shall be final and binding.
11. **Important Note:** Candidates are advised to make the Admission Fee payment only if they are willing to accept the seat offered under this Selection List. In case the available seats in the selected programme cannot be filled in accordance with the applicable merit and category-wise reservation, eligible candidates may, subject to seat availability and fulfillment of the prescribed eligibility criteria, be given an opportunity to opt for B.Sc. Computer Science & Data Analytics or B.Sc. Mathematics & Computing, as applicable. Such programme change shall be considered only with the candidate's consent and subject to the rules and approval of the University. Any fee paid shall be refundable, if applicable, only in accordance with the UGC prescribed fee refund rules.
