1. The programme's Admission Fee is provided in the fee table below.

2. Candidates whose names appear in the Selection List – II shall pay the prescribed Admission Fee on or before **12 August 2026**.
3. The Admission Fee may be paid either by scanning the QR Code provided by the University or through the Bank Account details notified by the University.
4. After successful payment, candidates shall upload the Admission Fee payment receipt along with the required details through the prescribed Google Form on or before **12 August 2026**.
5. Candidates shall retain the original payment receipt and produce the same at the time of document verification/admission, if required.
6. Failure to pay the Admission Fee and upload the payment receipt through the prescribed Google Form within the stipulated time shall be treated as unwillingness to accept the admission offer. Such candidature shall not be considered under Provisionally Admitted List, and the resultant vacancy shall be offered to the next eligible candidate from the Waiting List/next Selection List strictly in the order of merit and applicable reservation policy.
7. Admission shall be confirmed only after successful verification of eligibility, original documents, completion of all prescribed fee formalities, and approval by the University.

General Instructions

1. This Selection List – II has been prepared strictly on the basis of merit, applicable reservation policy, seat availability, and the eligibility criteria prescribed by Sammakka Sarakka Central Tribal University.
2. Inclusion of a candidate's name in the Selection List – II does not guarantee admission. Admission shall be confirmed only after successful verification of eligibility, original documents, reservation claims (where applicable), payment of the prescribed fees, and approval by the University.

3. Candidates are advised to carefully verify that they fulfill the prescribed eligibility criteria for the respective programme before making any payment. If, at any stage, a candidate is found ineligible or any information/documents furnished are found to be false or incorrect, the candidature/admission shall be cancelled.
4. Registration Fee (Special Provision): The University observed that some candidates, despite completing and submitting their application forms, were unable to upload the registration fee payment receipt on the admission portal. As a one-time special provision, such candidates have been considered while preparing this Selection List – II. However, candidates who have not yet paid the prescribed registration fee or have not completed the required registration fee formalities, wherever applicable, shall complete the same on or before **12 August 2026**. Only candidates who complete the prescribed registration fee formalities within the stipulated time shall be considered for further processing of admission.
5. Candidates shall report for admission with all original certificates and one set of self-attested photocopies on the date and time notified by the University.
6. Candidates who fail to complete the prescribed fee payment formalities within the stipulated time shall forfeit their claim for admission under Selection List - II.
7. Any vacancy arising due to non-payment of fees, non-reporting, cancellation of admission, withdrawal, or any other reason shall be filled strictly from the Waiting List/next Selection List in the order of merit and applicable reservation policy.
8. The decision of Sammakka Sarakka Central Tribal University on all matters relating to admissions shall be final and binding.
